RULES & REGULATIONS

1-Definitions

A-These rules and regulations are an integral part of the agreement between the Organizers and the Exhibitor.

B-Once application for participating has been made and the participation is confirmed contents will have the implied status of a business contract governed by these present rules and regulations. This contract limits the liability of the organizers and their authorized agents only to terms as outlined against the charges and specified on the application form.

C-Memoranda and instructions to Exhibitors issued by the organizers from time to time (whether during and Exhibitors meeting or otherwise) are all be considered supplementary and not replacing these rules and regulations. Nor the terms on the application/contract form.

2-APPLICATION, Contract, payment:

A- An application for space is fully deemed here as conclusive evidence of the applicant's agreement to pay the dues and charges, and once participation has been confirmed the two parties (organizers and participant) would be considered to have entered into a binding contractual agreement.

B-Payments are due on the dates and schedules as mentioned on this form non-compliance will result in cancellation of any reserved stand space.

C-Exhibitors can not claim any rights to any services and facilities without having duly paid the full amount.

D-After participation has been confirmed, withdrawal from the exhibition for whatever reason would entail 50% cancellation charges, of the stand rental up to two months before the exhibition and 100% thereafter.

E-Organizers reserve the absolute right to refuse participation to any applicant without having to assign any reasons. In such cases total deposit money sent with the application would be refunded.

3-Exhibits, Stands, Build-up:

A-The organizer will make every endeavor to accommodate exhibitors on stand space reserve or booked by them, but will reserve the right to change or reallocate areas in the interest of the exhibition as a whole and no guarantee can therefore be given.

B-Exhibitors under space cover contract would be provided within the agreed fees, a pre-fab.shell scheme, which can't be changed or altered by the occupying exhibitors.

C-Stand interiors are the responsibility of the exhibitors. Organizers reserve the rights to suggest any modifications and have them effected.

D-Exhibitors reserving open space will be allotted their required floor areas on the floor plan, where they can erect their own stands and booths ,these to be approved the organizers technical management at least 40 days prior to the exhibition.

E-All services not stated on the application form and if required by the exhibitors will be changed independently by appointed contractors of the organizers.

F-Exhibitors should occupy their stands and ready at least 3 hours before the time of the official opening of the exhibition. Under no circumstances can exhibitors dismantle their exhibits and withdraw from the exhibition earlier than the official closing of the same.

4-Safety, Insurance, Liabilities and Limitations:

A-The exhibition is covered under a general policy of insurance for the liabilities of the organizers but exhibitors liabilities their spaces, labor and staff's insurance and third party are their own liabilities.

B-Organizers undertake no responsibility for loss, theft or pilferage of exhibits during the exhibition period. Valuables and precious exhibits can be deposited for safekeeping under sealed packaging with the organizers.

C-In no event shall the exhibitor have any claim for damages of any kind against the organizer on respect of loss or damages due to the prevention, postponement or abandonment of the exhibition, caused by whatever reason. Exhibitors are advised to cover themselves by their own insurance policy.

D-In case of premature closure or abandonment of the exhibition, organizers shall be entitled to obtain all sums paid by the exhibitors or such part thereof as found justified for incurred expenses.

E-The transportation of the exhibits to and from Qatar is the sole responsibility of the exhibitors. For ease of service the organizers have appointed an official Freight – Forwarding Agent and exhibitors are advised to utilize their services.

F-Exhibitors undertake to acknowledge that they are participating at their own free will and decision and the contract entails no promise, oral or written, from the organizers as to the amount or level of business from the exhibition and/or its success.
